STATEMENT OF THE CASE

COG Operating LLC, (“COG”) seeks an order from the Oil Conservation Division making permanent the Special Rules adopted by the Division under Order No. R-13523 for the Dodd Glorieta Upper Yeso Pool (Pool Code 97917) and the Burch Keely Glorieta Upper Yeso Pool (Pool Code 97918).

In Order No. R-13523, Special Rules for the Dodd-Glorieta-Upper Yeso Pool and for the Burch Keely-Glorieta-Upper Yeso Pool were established allowing for a depth bracket allowable of 300 stock tank barrels of oil per day and a limiting gas-oil ratio of 3000 standard cubic feet of gas per barrel of oil. Additionally, the Special Rules limit the number of vertical wells which may simultaneously produce from the Blinebry formation to four (4) and from the Paddock formation to seven (7). Under the terms of Order No. R-13523, the Special Rules will expire if not made permanent by the Division.


